

INDEPENDENT ASSURANCE REPORT

To the management of GlobalSign NV/SA ("GlobalSign"):

Scope

We have been engaged, in a reasonable assurance engagement, to report on GlobalSign management's assertion that for its Certification Authority (CA) operations at its locations as detailed in [Appendix D](#), throughout the period April 1, 2022 to March 31, 2023 for its CAs as enumerated in [Appendix B](#) and [Appendix C](#), GlobalSign has:

- ▶ disclosed its code signing ("CS") certificate lifecycle management business practices in the applicable versions of the Certificate Practice Statements and Certificate Policies, as enumerated in [Appendix A](#), including its commitment to provide CS certificates in conformity with the CA/Browser Forum Requirements on the GlobalSign's Website, and provided such services in accordance with its disclosed practices
- ▶ maintained effective controls to provide reasonable assurance that:
 - CS subscriber information was properly collected, authenticated (for the registration activities performed by the CA, Registration Authority (RA) and subcontractor) and verified;
 - The integrity of keys and CS certificates it manages is established and protected throughout their life cycles
- ▶ maintained effective controls to provide reasonable assurance that its CS Timestamp Authority is operated in conformity with the applicable CA/Browser Forum Baseline Requirements for the Issuance and Management of Publicly-Trusted Code Signing Certificates
- ▶ maintained effective controls to provide reasonable assurance that it meets the Network and Certificate System Security Requirements as set forth by the CA/Browser Forum that are incorporated by reference

and, for its CAs in scope for Principle 3: Extended Validation Code Signing Service Integrity as enumerated in [Appendix C](#):

- ▶ maintained effective controls to provide reasonable assurance that:
 - EV CS subscriber information was properly collected, authenticated (for the registration activities performed by the CA, Registration Authority (RA) and subcontractor) and verified;
 - The integrity of keys and EV CS certificates it manages is established and protected throughout their life cycles

in accordance with the [WebTrust Principles and Criteria for Certification Authorities - Code Signing Baseline Requirements - Version 2.7](#).

GlobalSign does not operate any CS Signing Authority. Accordingly, our procedures did not extend to controls that would address those criteria.

Certification authority's responsibilities

GlobalSign's management is responsible for its assertion, including the fairness of its presentation, and the provision of its described services in accordance with the [WebTrust Principles and Criteria for Certification Authorities - Code Signing Baseline Requirements - Version 2.7](#).

Our independence and quality management

We have complied with the independence and other ethical requirements of the *Code of Ethics for Professional Accountants* issued by the International Ethics Standards Board for Accountants, which is founded on fundamental principles of integrity, objectivity, professional competence and due care, confidentiality and professional behaviour.

The firm applies International Standard on Quality Management (ISQM) 1, Quality Management for Firms that Perform Audits or Reviews of Financial Statements, or Other Assurance or Related Services Engagements and accordingly maintains a comprehensive system of quality control including documented policies and procedures regarding compliance with ethical requirements, professional standards and applicable legal and regulatory requirements.

Practitioner's responsibilities

Our responsibility is to express an opinion on management's assertion based on our procedures. We conducted our procedures in accordance with International Standard on Assurance Engagements 3000, *Assurance Engagements Other than Audits or Reviews of Historical Financial Information*, issued by the International Auditing and Assurance Standards Board. This standard requires that we plan and perform our procedures to obtain reasonable assurance about whether, in all material respects, management's assertion is fairly stated, and, accordingly, included:

1. obtaining an understanding of GlobalSign's CS and EVCS certificate lifecycle management business practices, including its relevant controls over the issuance, renewal, and revocation of CS and EVCS certificates, and CS and EVCS Timestamp Authority certificates and obtaining an understanding of GlobalSign's network and certificate system security to meet the requirements set forth by the CA/Browser Forum;
2. selectively testing transactions executed in accordance with disclosed CS and EVCS certificate lifecycle management practices
3. testing and evaluating the operating effectiveness of the controls; and
4. performing such other procedures as we considered necessary in the circumstances.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

GlobalSign's management has disclosed to us the attached comments ([Appendix E](#)) that have been posted publicly in the online forums of the Bugzilla site, as well as the online forums of individual internet browsers that comprise the CA/Browser Forum. We have considered the nature of these comments in determining the nature, timing and extent of our procedures.

The relative effectiveness and significance of specific controls at GlobalSign and their effect on assessments of control risk for subscribers and relying parties are dependent on their interaction with the controls, and other factors present at individual subscriber and relying party locations. We have performed no procedures to evaluate the effectiveness of controls at individual subscriber and relying party locations.

Inherent limitations

There are inherent limitations in the effectiveness of any system of internal control, including the possibility of human error and the circumvention of controls. For example, because of their nature, controls may not prevent, or detect unauthorised access to systems and information, or failure to comply with internal and external policies or requirements. Also, the projection to the future of any conclusions based on our findings is subject to the risk that controls may become ineffective.

Opinion

In our opinion, throughout the period April 1, 2022 to March 31, 2023, GlobalSign management's assertion, as referred to above, is fairly stated, in all material respects, in accordance with the [WebTrust Principles and Criteria for Certification Authorities - Code Signing Baseline Requirements - Version 2.7.](#)

This report does not include any representation as to the quality of GlobalSign's services beyond those covered by the [WebTrust Principles and Criteria for Certification Authorities - Code Signing Baseline Requirements - Version 2.7,](#) nor the suitability of any of GlobalSign's services for any customer's intended purpose.

GlobalSign Management's Assertion

GlobalSign NV/SA (“GlobalSign”) operates the Certification Authority (CA) services for the root and other CAs in scope as enumerated in [Appendix B](#) and [Appendix C](#), and provides code signing (“CS”) CA services.

The management of GlobalSign is responsible for establishing and maintaining effective controls over its code signing services, including its network and certificate security system controls, its code signing business practices disclosure on its [website](#), code signing key lifecycle management controls, and certificate lifecycle management controls. These controls contain monitoring mechanisms, and actions are taken to correct deficiencies identified.

There are inherent limitations in any controls, including the possibility of human error, and the circumvention or overriding of controls. Accordingly, even effective controls can only provide reasonable assurance with respect to GlobalSign’s Certification Authority operations. Furthermore, because of changes in conditions, the effectiveness of controls may vary over time.

GlobalSign management has assessed its disclosures of its certificate practices and controls over its CS CA services.
