This limited warranty plan extends to all GlobalSign certificates issued by any GlobalSign Registration Authority or a GlobalSign Local Registration Authority located anywhere in the world.

#### Possible risks covered

GlobalSign's Limited Warranty Plan warrants against the remote possibility of any of the following risks occurring:

# Risks for a GlobalSign RA

A subscriber or relying party are protected for errors that might occur in the identification process resulting in damages for them. Although registration with GlobalSign is subject to strict procedures and the RA personnel assigned therefore are thoroughly trained and duly accredited, such errors might still occur.

A subscriber can equally insure against the risk of a Registration Authority or Local Registration Authority losing documents that are used to verify the identity of a subscriber and support the issuance of a GlobalSign certificate.

# Risks for GlobalSign and a GlobalSign CA

GlobalSign root signs other CAs. This limited warranty scheme assures that subscribers and relying parties of GlobalSign as well as any GlobalSign CA are protected against risks associated with the loss or compromise of the top root CA private key.

## **Limited warranty plan caps**

GlobalSign limits the maximum amount it may pay to a subscriber according to the class of the certificate as explained in the table below:

#### **Governing law**

If the contract party is GMO GlobalSign Limited, this Agreement shall be governed by, construed under and interpreted in accordance with the laws of England and Wales without regard to its conflict of law provisions. Venue shall be in the courts of England.

If the contract party is GMO GlobalSign, Inc., this Agreement shall be governed by, construed under and interpreted in accordance with the laws of the State of New Hampshire U.S.A. without regard to its conflict of law provisions. Venue shall be in the courts of the New Hampshire State. If the contract party is GMO GlobalSign Pte. Ltd., this Agreement shall be governed by, construed under and interpreted in accordance with the laws of Singapore without regard to its conflict of law provisions. Venue shall be in the courts of Singapore.
